We are committed to upholding high health and safety standards in organizing the conference, which will take place in hybrid format on November 11 and 12, 2021, with Palazzo Castiglioni, in Milan, Italy as our physical hub.

THE CONFERENCE

The two-day program is structured with keynotes and panels taking place in the mornings and parallel breakout sessions in the afternoons. All stated times are CET (Central European Time zone).

Day 1 will kick-off at 9:30am with a lunch break at 12:30pm, followed by afternoon sessions that begin at 2pm and conclude at 7pm.

At the end of Day 1, the Networking Reception will take place from 7pm onward for in-person delegates only.

Day 2 will kick off at 9:30am with a lunch break at 1pm. Afternoon sessions will begin at 2pm and conclude at 5pm.



__THE VIRTUAL EVENT

Virtual attendees can access the live streaming through the agenda on the website and via the app. Logging in requires entering the email you registered with or typing the ticket number and email.

All conference sessions will be recorded and available for playback on demand by attendees.

__ENTERING THE VENUE

To gain access to Palazzo Castiglioni, you may need to present one or more of the following:

- EU Digital Covid Certificate (ie, "Green Pass")
- proof of negative PCR test taken within 48 hours before entry
- proof of recovery from Covid less than six months prior to the event.

Please note that you will also be requested to complete and sign the Health Self-Declaration Form.

At the entrance, a hostess will check your body temperature.

Please do not attend the conference if you feel unwell or have any symptoms of Covid.

CONFERENCE SAFETY

All attendees are expected to wear masks while on the conference premises. We will be pleased to provide you with complimentary FH masks.

To prevent the risk of contagion and spread of Covid, we also encourage you to follow the hygiene standards: wash or sanitize your hands frequently, do not shake hands, and follow the flow design to avoid mass gatherings.

TRAVELING TO ITALY

Arrivals are permitted from most of Europe: Andorra, Austria, Belgium, Bulgaria, Cyprus, Croatia, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Monaco, the Netherlands, Norway, Poland, Portugal, Czech Republic, Romania, Slovakia, Slovenia, Spain, Sweden and Switzerland.

As of August 31, those who've been fully vaccinated with an EU-approved vaccine more than two weeks earlier and can produce a negative PCR test, taken within 72 hours prior, can enter without having to quarantine.

Passengers entering Italy are currently required to complete a Passenger Locator Form via the EUdPLF application available at <https://app.euplf.eu/>.

If you do not hold the EU Digital Covid Certificate, we recommend checking the entry restrictions that apply to your specific situation.
